### Nominations for Annual Elections

1. For the post of President-elect and Vice-President the candidate should have served for at least two years as elected member of the Governing Council.
2. For the post of Governing Council Member the intending candidate should have been an active member of the Society for at least two years.
3. Associate, Hon. Life Members and corporate members are not eligible for any post of the Governing Council and do not have voting rights.
4. Proposer and Seconder to nominate a candidate should be bonafide member of the Society.
5. Each candidate is requested to send a brief resume (upto 250 words) for circulation along with ballot papers. Canvassing by letters, e-mail or SMS is not acceptable and may debar the candidate or their supports from election process.
